4. FIRST AID MEASURES

- Eye Contact: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.
- Skin Contact: Wash with soap and water. If injury occurs, or if discomfort or irritation persists contact a physician.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media
